The FCCA Board of Directors and the Education Committee have created an agenda full of interesting and enriching educational sessions. Peer to peer breakout sessions will also be offered, as they continue to be very popular among our membership. The educational sessions will be led by local court trainers, as well as Federal Judicial Center trainers and staff from the Administrative Office.

We hope you will consider joining us for our centennial celebration. Registration will be open to all current FCCA members, and the cost is \$450 and \$250 for retirees. This fee covers three solid days of education and includes breakfast on Tuesday, Wednesday, and Thursday and dinner on Thursday evening.
